Global 'All but essential travel' Advisory – Exempt Countries

As part of the COVID-19 recovery process, the Foreign & Commonwealth Office (FCO) has updated the travel advice for a number of countries to exempt them from the Global 'All but essential travel' advisory.

These countries have been assessed as no longer presenting an unacceptably high risk to British people travelling abroad. The FCO travel advice is based on risks to British nationals, including in-country public health assessments.

Whilst some countries have been exempt from the global 'All but essential' restrictions, those intending to travel to those countries will be required to:

- **Comply with country specific entry requirements or restrictions included within the individual country travel advice**
- **Comply with any country specific requirements on local COVID-19 measures that will need to be followed.**
- **Comply with any specific FCO advice against travel to parts of the country included in the country specific advice (non-COVID related)**

All people returning to the UK will need to comply with the UK border control measures and may be subject to 14-day quarantine on arrival in the United Kingdom. From 10 July 2020 the Department for Transport has introduced quarantine exemption rules known as 'travel corridors' for some countries. Note that the quarantine exemptions when arriving at the UK borders may be different for England, Scotland Northern Ireland and Wales.

To help Members navigate through this process, we have produced a list of the countries that appear on the FCO exemption list, with, mandatory destination entry requirements and quarantine rules on arrival in the UK.

ENTRY RESTRICTED

Currently borders are closed/UK nationals not permitted



MEDICAL

A negative COVID-19 test certificate is required on entry/COVID-19 test is undertaken on arrival for a fee



QUARANTINE

People are subject to a mandatory quarantine period on arrival in the destination/Maybe a government quarantine facility for a fee



BOOKING DETAILS

People are required to provide booking details/Online passenger information required/permit necessary



TRANSIT

People can transit to another country if the connecting flight leaves from the same airport/staying airside







